### 7.1 Doors Open

The Committee suggested that funds be reserved in future budgets to reimburse private homeowners for insurance coverage, if required.

The Committee discussed when to schedule the next Doors Open Brockton event, noting the many events scheduled in 2026 including the Bruce County Ploughing Match in Walkerton, Walkerton Homecoming, and the Municipal Election.

### 7.2 Heritage Trust Fund Program By-Law Comparison

The Committee discussed the terms of the loan program, and whether the interest rate for the loan could be changed to provide more incentive for heritage property owners, such as prime minus half, or prime minus one.

The Committee discussed where the interest collected is allocated within the budget. **Action: The Secretary will inquire with the Finance Department.** 

The Committee discussed whether loans should be increased to \$30,000 with a lower interest rate, and whether grants should be limited to public institutions, or a separate amount should be given to private individuals versus public institutions. Ted interest rate 1/2 prime suggestion

The Committee noted encouragement for the loan program to ensure funds are replenished for future Committee's needs.

The Committee discussed increasing the loan amount with a lower interest rate if possible and whether to segregate grants for certain circumstances. The Committee suggested that there should be a difference between non-profit properties and private properties.

The Committee deferred consideration to the next meeting after learning more information about the interest rate.

### 7.3 Municipal Heritage Register

The Committee discussed holding a public meeting in 2025 and sending a letter to the current "listed" properties inviting them to the meeting. At this time the Committee has no interest in proceeding to formally designate any of the listed properties, leaving that decision up to the property owner(s).

## 7.4 Award for Outstanding Contributions on Preserving and Promoting Brockton Heritage

The Committee discussed purchasing a wall plaque to display at Municipal Office recognizing the award winners, and having a separate recognition item for the winner to keep.

The Committee plans to advertise the award during Heritage Week which will occur February 17-23, 2025.

The Committee discussed their plans for the first award winner, with the intention of creating a memorial award.
